

A Career in Caring...

Employment of licensed practical and licensed vocational nurses (LPNs and LVNs) is projected to grow 9 percent from 2019 to 2029, much faster than the average for all occupations. As the baby-boom population ages, the overall need for healthcare services is expected to increase. LPNs and LVNs will be needed in residential care facilities and in home health environments to care for older patients. A number of chronic conditions, such as diabetes and obesity, have become more prevalent in recent years. LPNs and LVNs will be needed to assist and care for patients with these and other conditions. In addition, many procedures that once could be done only in hospitals are now being done outside of hospitals, creating demand in other settings, such as outpatient care centers.

PRACTICAL NURSING at OCEAN COUNTY VOCATIONAL TECHNICAL SCHOOL

The OCVTS Practical Nursing program was formed in 1959. The program is approved by the New Jersey Board of Nursing and the Department of Education. Graduates are eligible to take the New Jersey Board of Nursing Examination for qualification as a Licensed Practical Nurse (NCLEX-PN).

The Practical Nursing Program has a competitive admission process. Class sizes are limited and the application process may take up to one year to complete. The course is 10 months in length, excluding holidays and weekends. Forty percent of the time is devoted to classroom theory and laboratory. The remaining time is devoted to clinical experience. Curriculum includes the study of anatomy and physiology, fundamentals, geriatrics, interpersonal relations, medical/surgical, nursing process, nutrition, obstetrics, pediatrics, pharmacology, psychiatry, as well as skills lab and clinical competency.

Job Description

A practical nurse is trained to care for acute, subacute, convalescent and chronically ill patients under the direction of a licensed physician or registered professional nurse.

Employment Opportunities

Public recognition of the need for more practitioners in health and medical care has increased employment opportunities for medical professionals. Licensed practical nurses may find employment in hospitals, industry, private homes, nursing homes, clinics, and public and federal health agencies.

Diplomas and Licensing

Graduates will be awarded an Ocean County Vocational Technical School diploma by the Ocean County Vocational Technical School Board of Education. Students are then eligible to take the state licensing examination. Licensed practical nurses are qualified for employment in any New Jersey hospital or other institution providing nursing care.

Entrance Requirements

Applicants must be at least 18 years of age and have satisfactorily completed four years at an accredited high school or obtained high school completion status.

- **Application submitted with fee**
- **Written essay**
- **Pre-nursing seminar**
- **Online pre-admission test (TEAS)**
- **High school transcript or HSEA (GED)**
- **Criminal background check**
- **Negative drug screening**
- **Interview with faculty member**

When a file is completed with all of the above, the admissions team will evaluate the candidate.

Applicants accepted must have a satisfactory health record as evidenced by a physical examination which includes lab tests and immunizations.
